

## CAMP NEWS:

# PROPOSED CHANGES TO CAMP BY-LAWS

---

All changes are in **BOLD print**, deletions are in red

**Article III: Nature**—The Brig.- General Benjamin G. Humphreys Camp, in furtherance of the Charge of Lt.-general Stephen D. Lee, **is a historical honor society and service organization dedicated to education and preservation and** shall be strictly patriotic, historical, educational, fraternal, benevolent, nonpolitical, non-racial, and nonsectarian.  
Reasoning: This change brings us in line with the National Constitution.

**Article IV, Membership; Section 2**—after the word “duplicate” in the last sentence add **“sent to the Division Adjutant and”**.  
Reasoning: Camp Adjutants will be sending a copy of a member’s SCV application to the Division level for an additional record keeping source.

**Article IV, Membership, Section 4**—Begin the sentence with **—All**.

Reasoning: This clarifies that National, Division and Camp dues & fees must accompany the application when submitted to the Camp Adjutant.

**Article V: Finances; Section 5**—Add the following sentence: **Revenue cannot be raised by means of a raffle, bingo, or any other method of games of chance.**

Reasoning: Internal Revenue laws prohibit this type of activity unless you have a license to do so.

**Article V: Finances; Section 6**—after Stars and Bars Fund, and the “Re-enactors Funds” which include but not limited to Co. D, CS Marines, Ft. Pemberton Re-enactors and the Jeff Davis Battalion..

Reasoning: The Re-enactors Fund has been removed to an account of their own and this money is no longer in the Camp’s account.

**Article VII: Officers and Their Duties; Section 1**— Rewrite the first sentence to read as follows: “ The **elected** officers of the Camp shall be Commander, First Lieutenant Commander, Second Lieutenant Commander, Adjutant / Treasurer, Judge Advocate and Color Sergeant / Quartermaster, and an Executive Committee.”After “...his Staff” in the second sentence add **—a Judge Advocate, —**. At the end of this Section add the following sentence: **— Contact information for all newly elected and appointed Camp Officers shall be printed one time in the Camp Newsletter and posted on the Camp Website as soon as practicable to include a minimum of email address and telephone number, with permission, for all Officers and mailing addresses for the Camp Commander and Camp Adjutant. If space permits, list mailing addresses for all other Officers.**

Reasoning: Adding the word “elected” clarifies who are elected versus those who are appointed. Judge Advocate is an appointed position, not an elected office. Executive Committee is not an office and is discussed in Article VIII. Sometimes an officer is elected or appointed who does not have a computer. Adding the phone numbers and mailing addresses will enhance communications.

**Article VIII: Executive Committee and their Duties; Section 2** – After the first sentence, add the following: **—The Commander shall chair the Committee but will not have a vote except to break a tie and he cannot make any motions. Robert’s Rules of Order shall govern the Committee.**

Reasoning: Just a clarification of who chairs the Committee and his duties

## NATIONAL NEWS:

### A MESSAGE FROM CIC CHUCK MCMICHEAL

The Sons of Confederate Veterans (SCV) has been informed that they may not march in the Homestead, Florida Veteran's Day Parade with the Confederate Battle Flag. The SCV is quite surprised by this anomaly. The SCV honors and respects the members of the VFW, in fact many veterans are members of both. All across the nation the SCV and VFW have worked together in harmony on many occasions to honor America's Veterans. However, the SCV condemns the decision by the local chapter of the Veterans of Foreign Wars in Homestead, the sponsor of the parade, as the Confederate Battle Flag is a banner which denotes the valor and bravery of some of America's most renowned veterans - the Confederate Soldier. By denying the SCV participation in the parade the Homestead post of the VFW has shown that it is no longer an organization that supports the memory of Veterans but is instead more interested in promoting an agenda of political correctness.

For the last 90 years Confederate Veterans have been recognized as U. S. Veterans by the United States Congress. The actions of the VFW show that they believe they have the authority to redefine who qualifies to be recognized as a veteran in defiance of a congressional statute. Further, the actions of the VFW, in denying the SCV entry into the parade, are repugnant to the sacrifice made by many millions of veterans who have fought to preserve the Rights of Americans as established in the Constitution.

This arbitrary action of the Homestead VFW Post is an affront to Southerners of all colors and ethnic backgrounds whose ancestors served honorably in the military of the CSA, and today continues to lead the nation in voluntary service and casualties suffered by U. S. Forces in conflicts around the world.

It is also greatly disappointing that the local Veterans of Foreign Wars post is allowing itself to be used in this manner.

The SCV urges the community in Homestead, Florida to express their rightful disappointment that the memory of one group of American Veterans, Confederate Veterans, are being disparaged by the Veterans of Foreign Wars.

Beauvoir, the Jefferson Davis Home and Presidential Library, will conduct a ground-breaking ceremony for the new Jefferson Davis Presidential Library and Museum on Sunday, December 6, 2009 at 2p.m. (This is the 120th anniversary of Jefferson Davis's death). The construction of the new Library is estimated to be 550 days. The J.C. Duke Construction Company of Mobile, AL will build the 25,500 sq. ft. structure. **The public is invited to attend the ceremony.**



In February 1864, General William Sooy Smith led a force of over seven thousand cavalry on a raid into the Mississippi Prairie, bringing fire and destruction to one of the very few "bread-baskets" remaining to the Confederacy. Smith's raid was part of General William T. Sherman's campaign to march across Mississippi from Vicksburg to destroy the railroad junc-

tion at Meridian. Both Smith and Sherman intended to burn everything in their path that could aid in the Southern war effort. It was a harbinger of things to come in Georgia, South Carolina and the Shenandoah Valley. But neither reckoned with General Nathan Bedford Forrest. Forrest's small Confederate cavalry force defeated Smith in a running battle that stretched from West Point to Okolona and beyond. Forrest's victory prevented Smith from joining Sherman and saved the Prairie from total destruction. Join Civil War historian Brandon Beck as he narrates this exciting story, with all the realities and color of cavalry warfare in the Deep South. Also included is a brief guided tour of the extant sites, preserved for future generations by the Friends of the Battle of Okolona, Inc.

We say little prayers for you every night, dear General Lee, and ask God to make you ever so happy. Please let us know about Santa Claus as soon as you can; we want to know for something very, very, very particular; but we can't tell even you why until Christmas time, so please to excuse us.

The above letter was sent the following day, and in about a week the answer was received:

My dear little friends:

I was very glad to receive your kind letter, and to know by it that I have the good wishes and prayers of three innocent little girls, named Lutie, Birdie, and Minnie. am very glad that you wrote about Santa Claus for I am able to tell you all about him. I can assure you he is one of the best friends that the little Southern girls have. You will understand this when I explain to you the reason of his not coming to see you for four years.

The first Christmas Eve of the war I was walking up and down in the camp ground, when I thought I heard a singular noise above my head; and on looking to find out from whence it came, I saw the queerest, funniest-looking little old fellow riding along in a sleigh through the air. On closer inspection, he proved to be Santa Claus. Halt! Halt!, I said; but at this the funny fellow laughed, and did not seem inclined to obey, so again I cried Halt!. And he drove down to my side with a sleigh full of toys. I was very sorry for him when I saw the disappointed expression of his face when I told him he could go no further South; and when he exclaimed, Oh, what will my little Southern children do! I felt more sorry, for I love little children to be happy, and especially at Christmas. But of one thing I was certain--I knew my little friends would prefer me to do my duty, rather than have all the toys in the world; so I said: Santa Claus, take every one of the toys you have back as far as Baltimore, sell them, and with the money you get buy medicines, bandages, ointments, and delicacies for our sick and wounded men; do it and do it quickly--it will be all right with the children. Then Santa Claus sprang into his sleigh, and putting his hand to his hat in true military style, said: I obey orders, General, and away he went. Long before morning he came sweeping down into camp again, with not only every thing I had ordered, but with many other things that our poor soldiers needed. And every Christmas he took the toy money and did the same thing; and the soldiers and I blessed him, for he clothed and fed many a poor soul who otherwise would have been cold and hungry. Now, do you not consider him a good friend. I hold him in high respect, and trust you will always do the same. I should be pleased to hear from you again, my dear little girls, and I want you ever to consider me,
