

### **NAACP Threatens Mississippi Boycott**

As a board appointed by Gov. Ronnie Musgrove debates whether to change the state flag, the NAACP is considering expanding its boycott of South Carolina to include Mississippi and Georgia. On Tuesday, at the NAACP's national convention in Baltimore, the group's Georgia chapter offered a resolution urging churches, businesses and corporations to avoid states where the Confederate battle flag or emblem is flown in public places. That specifically targets Mississippi and Georgia because the Confederate symbol is part of their state flags.



The resolution was adopted by national NAACP board members. It will not become NAACP policy until it is voted on by the 64-member national board of directors in October.

Musgrove recently appointed a commission to make a recommendation on whether the Confederate symbol should be removed from Mississippi's 106-year-old state flag. But the commission has until May of next year - well after the state Legislature convenes in January - to make a recommendation. Rep. Erik Fle ning, D-Jackson, said the flag should be redesigned quickly before NAACP activists demonstrate against Mississippi. "I don't want Mississippi's tourism and economy to be stunted because of some stubborn individuals who don't want to let go of the past," Fleming said. "The longer we prolong this issue, the harder it will be to resolve."

The Rebel flag issue caused tension on the Coast earlier this year, when residents, Coast NAACP-branches and other groups protested against Harrison County flying the flag at its Eight Flags display on the beach. The county removed the flags and plans to replace Eight Flags with a historical display that flies only the American flag.

In May, angered over government and community reaction to the flag issue and to Black Springbreak held on the Coast, the Biloxi branch of the NAACP called for a one-day "blackout," urging black consumers to refrain from spending money at unauthorized. The NAACP began its boycott of the South Carolina tourism industry Jan. 1 because the Rebel flag flew above the Statehouse dome. After months of legislative debate, the flag came down July 1 and a similar banner was raised at the nearby Confederate Soldier Monument. The NAACP said that is still too prominent and the boycott would continue and be expanded until the flag was off Statehouse grounds. South Carolina Attorney General Charlie Condon says he will continue to investigate a possible lawsuit against the NAACP over the boycott.

## Reparations for Slavery? By Walter Williams of the Jewish World Review

IF THE NOVEMBER ELECTIONS put Democrats in control of the House of Representatives, we can expect 1 hn Conyers, D-Mich., to introduce legislation that would set up a committee to decide who would qualify for reparations for slavery, whether they should be compensated in cash, land or some other payment, and how much each black person would receive. City councils in Chicago, Houston, Detroit and several other cities have already called for Congress to hold hearings on reparations.

First off, let me say that I agree with reparations advocates that slavery was a horrible, despicable violation of basic human rights. I'd also agree that were it possible slave owners should make reparations to those whom they enslaved. The problem, of course, is both slaves as well as their owners are all dead. Thus, punishing perpetrators and compensating victims is out of the hands of the living. Reparations advocates, however, want today's blacks to be compensated for the suffering of our ancestors. If we acknowledge that government has no resources of its very own, and that to give one American a dollar government must first confiscate i from some other American, we might ask what moral principle justifies forcing a white of today to pay a black of today for what a white of yesteryear did to a black of yesteryear? We might also recognize that a large percentage of today's Americans, be they of European, Asian, African or Latin ancestry, don't even go back three or four generations. Are they to be held accountable and taxed for slavery and why? Then there's the fact hat white slave owners aren't the only villains in the piece. In Africa, Moslems dominated the slave trade in 18th and 19th centuries. Africans also engaged in slave trade with Europeans. In fact, there was plantatic 1 slavery in some parts of Africa, such as the Sudan, Zanzibar and Egypt. Thus, a natural question arises: In reparations advocates hold those who sold blacks into slavery subject to reparations payments? After all slevery, of the scale seen in the western hemisphere, would have been all but impossible without the help of Africans and Arabs. Incidentally, President Clinton apologizing for slavery in Africa, of all places, is stupid - apologizing to descendants of slave traders for slavery in America.

Though it's not politically correct to say, today's blacks benefitted immensely from the horrors suffered by our ancestors. You say: "What do you mean, Williams? Would you run that by us?" Most black Americans are in the solid middle class. In fact, if we totaled the income black Americans earned each year, and thought of ourse yes as a separate nation, we'd be the 14th or 15th richest nation. Even the 34 percent of blacks considered to be poor are fairly well off by world standards. Had there not been slavery, and today's blacks were born in a frica instead of the United States, we'd be living in the same poverty that today's Africans live in and under the same brutal regimes. If reparations were to be made, then what? Would reparations payments accompass what the 6 trillion dollars spent since 1965 on the War on Poverty didn't? Let's face the fact that there's not one thing anyone can do to change the past. There's a lot we can do about the future. Dwelling on the past comes at the expense of preparing for the future. There's one condition where I might fall prey to the reparations temptation. The federal government owns up to 90 percent of the land in western states such as Alaska, Jevada, New Mexico and California. Turning that land over to blacks, and hence into private hands, might not be a bad

### New Pro-Confederate Center Opens in Wiggins, Mississippi

# HISTORIC CONFEDERATE NATIONAL ORIGIN CLAIM SETTLES

A Federal lawsuit that settled in July is the first ever settlement of a Federal claim alleging discrimination based or National Origin - Confederate Southern American! Kathy Knight filed a pro-se Federal discrimination claim against Ben Mynatt Chevrolet of Concord, North Carolina in 1999 alleging sexual harassment, discrimination based on her being proud of her Southern Heritage and hostile work environment leading to her resignation from Mynatt's employment. Kirk D. Lyons assisted Kathy in drafting the pleadings and later became sounsel of record with local counsel Robert D. Palmer.

At the time, Knight was active on behalf of her daughter, Katie Knight, over the Cabarrus County School's policy on Confederate symbols. Mynatt's wife was Chairman of the Cabarrus County Board of Education. Kathy's mase was settled by Palmer at a court ordered arbitration on June 27 in Greensboro for an undisclosed amount while Lyons was participating in the Branch Davidian Civil trial in Waco, Texas. "This is the first case of its kind to settle out of Federal Court so it is historic," said Lyons of the settlement. "May there be many more." he added.

Kath Knight, who has been actively supporting the Alcoa workers, shared a copy of her lawsuit with one of the workers disciplined for displaying Confederate symbols. "When management found out that the case had settled, they sat up and took notice!" Knight said. SLRC advises any Southern worker seeking protection from discrimination under National origin should fill out all federal and state forms requiring information on race with "Confederate Southern-American."

SLRC will be handling another EEOC appeal on behalf of a Confederate Southern-American in Virginia later this Summer.





### SCV National Convention: Confederate Flag Fight to Continue

CHARLESTON, S.C. (AP) - Members of the Sons of Confederate Veterans said Thursday the battle over the Confederate flag may be lost in South Carolina, but they will fight to keep it flying in Georgia and Mississippi. With more than 800 national members here this week for their annual reunion, Danny Wheeler, national commander in chief, announced an informal proclamation of support for the flag at one of the group's business meetings. No formal vote was taken.

"As far as South Carolina, that's over and done with," Wheeler said. But the group would discuss plans to defend the flag in other Southern states, he said. Georgia and Mississippi incorporate the Confederate emblem of crossed blue lines with white stars on a red background on their state flags. Mississippi Gov. Ronnie Musgrove recently appointed a board to review whether that flag should be changed and opponents in Georgia also have pushed for a change there.

The group, which was formed in the 1890s to honor Confederate veterans, tried to keep the Confederate flag flying over the Statehouse in Columbia. Faced with a boycott of the state by the National Association for the Advancement of Colored People and pressure from business groups, legislators decided to lower the flag from the dome July 1 and move it to a soldiers' memorial on Statehouse grounds.

Groups like the Sons of Confederate Veterans say the flag is a symbol of their heritage. Opponents say it denotes racism. The NAACP has vowed to continue its boycott until the flag is moved off the Statehouse grounds.

Randall Burbage, commander of the group's Charleston branch, said the Statehouse might not be the most appropriate place for the flag, but he staunchly denied it stood for anything but heritage. "Some people have set a course bound for destroying our heritage," he said. "It's considered a bad thing to celebrate the sacrifices of our ancestors." Black soldiers also fought for the Confederacy and the flag represents their sacrifices, too, Burbage said. "It's not about racism," agreed Nelson Winbush of Kissimmee, Fla., one of the group's few black members. "It never was. Anyone who thinks so is just ignorant." At the funeral for his grandfather, who fought for the 7th Cavalry in Tennessee, a Confederate flag was draped over the gray coffin, Winbush said.
