

#### Adjutant's Report by Dan McCaskill — December 1, 2018

6:00 pm: The Meeting was called to order by Commander Larry McCluney at 6:00 pm. Camp Chaplain Earl McCown was called upon to open the Meeting with a word of prayer and blessing. This was followed by Color Sergeant Earl Allen leading everyone in the Pledge and salutes to our Flags followed by the reading of "The Charge" given to us by L/G Stephen D. Lee.

Larry welcomed everyone to the meeting and decided to conduct some Camp Business allowing the Ladies of the OCR Chapter to set-up the evening meal.

Program: Our "program" for the evening was preparing our nine Christmas Care Packages for shipment overseas to arrive before Christmas for the soldiers our Camp "adopted". Five ladies and six gentlemen donated the items for the packages plus donations to help cover the shipping costs. An additional appeal was sent to our thirty-six absent Camp members for funds to cover the shipping costs and as of this writing (Dec 14th) I have received donations from three members.

Officer Reports: 1st Lt. Commander: Zack Kiker, the speaker was set for January with Terry Winchell speaking at the Lee-Jackson Banquet on January 19th; 2nd Lt. Commander: Jimmy Alford was absent; Adjutant: Dan McCaskill reported little has happened since the last Camp Meeting. He reported spending \$48.15 for computer ink. The account balance stands at \$1,295.26 which includes \$330 for Initiative 62; Ella Palmer OCR: Sandra announced the Chapter is preparing for our Lee-Jackson Banquet and is accepting donation of items for

the raffle.; Lt. C-I-C: Larry reported the SCV is now looking for a new Executive Director with the resignation of Mike Landree and that Tom Strain is acting interim Executive Director. Changes have been made at Elm Springs and business is running smoother. Headquarters will be addressing the recent demonstration at Oxford wanting to have the Confederate Memorial removed from the Ole Miss Campus. With no other reports, Larry recessed the meeting for the evening meal.

Camp Business: Our Lee-Jackson Banquet, the meats to be served will be roast beef and broiled chicken to accommodate 60 people. To cover the cost of the meat, a motion was made by Kenneth Ray to charge everyone over twelve \$5 per person to be paid in advance of the banquet. The motion was seconded by Earl McCown and passed. Invitations for the Banquet will be sent by email to members and card invitations sent to selected nonmembers. The Ladies of the OCR will be putting together a gift basket for our featured speaker, Terry Winchell. Anyone wanting to be part of the Color Guard for the evening needs to contact Larry McCluney (1-662-4537212). It was decided to postpone selecting a recipient for the H. L. Hunley JROTC Medal until next year. With no other business coming before the Camp, a motion was made, seconded and passed to close the business session.



The red field represents the Blood of Christ. The white border represents the Protection of God. The blue "X" represents the Christian Cross of Saint Andrew, the first Disciple of Christ Jesus and Patron Saint of Scotland. The 13 stars represent the 13 Southern States of Secession. Thus, the message in the Confederate Battle Flag is: "Through the Blood of Christ. with the Protection of God, We, the Thirteen States, are united in our Christian fight for liberty."

Traveling grace was given by Earl McCown and the Meeting was closed. Again, attendance was very low with eleven in attendance.



# Confederate Chaplains



#### From the Chaplain's pen ... Earl McCown

Early in the year of 1861, there was an excitement in the air. War was inevitable! Younger Southern men were anxious to "join up". They were sure that they "whip" those Northern people in a few short weeks, or even less. The older men weren't near as anxious and they were even less sure that this would be a short war. They were torn between "answering the call" and the crops in the fields at home. Our Southern women were supportive of the troops, but they too were fearful that they would surely face hardships and deprivations they had never even dreamed of before.

The boys in blue were just as anxious as their gray-clad foe. They too, were sure that this would be a very short "lark". The Northern women were not as anxious as their Southern counterparts. They didn't worry about crops in the ground; but who would run their factories? Unlike the men of the South, these Northern men didn't all "join up", many stayed home to run these factories.

Now, here it is January 1862, a New Year, and both sides find themselves, not in a short scrimmage, but a prolonged war. The thrill of serving for the boys in gray, has changed to a daily concern, not so much for themselves, but for the safety and well-being of the family at home. Who was going to break the ground and plant the crops this spring. Surely, the women shouldn't be expected to do this by them-

These concerns were not helped by the Chaplain's preaching, such as Ecclesiastes, Chapter 3, (verses 1, 2 and 8, 1 "To every thing there is a season, and a time to every purpose under the heaven: 2 A time to be born, and a time to die; a time to plant, and a time to pluck up that which is planted; 8 A time to love, and a time to hate; a time of war, and a time of peace."

The thrill of battle was just about over for the boys on both sides, and hearing the Sermons of the Chaplain; many men, young and old alike, decided to walk off and take care of business at home. Some were given leave, others took leave on their own!

The women at home were praying that the message in Isaiah 2:4, would surely come to fruition soon: "...and they shall beat their swords into plowshares, and their spears into pruninghooks: nation shall not lift up sword against nation, neither shall they learn war any more."

We would do well to pray for the fulfillment of this Scripture, as well!



#### For the Ladies:

#### A Most Remarkable Woman Virginia "Ginny" Moon (1844 - 1925)

Perhaps John Duncan will wish he had tripped over the marker for this remarkable woman on his visit to Elmwood Cemetery with Dr Curt Fields, aka General Grant. Curt would appreciate her connection with General Grant. But for his careful reverence perhaps he would have. Virginia "Ginny" Moon was a Confederate spy during the War Between the States who later became a movie star in Hollywood. When the war began, Ginny, also known as "The Ginger Girl," or "Ginnie" was a teenager in school at the Oxford College for girls in Ohio. She asked the school to allow her to

return home to her mother in Memphis; when they refused, she took a gun and shot all the stars out of the Union flag in the school's courtyard, no mean feat. The school relented and let the troublesome girl go home, released into the custody of her sister Lottie and brother-in-law Jim Clark, who were also living in Oxford at the time. Ginny helped the Confederacy by smuggling urgently needed medical supplies and information across the lines to Confederates several times and even tried once to hide a rifle down the back of her dress.

When the war ended, Ginny returned to Memphis and opened a boarding house. In the 1920's, she moved to Hollywood and appeared in character roles in two silent movies, Robin Hood and The Spanish Dancer. Robin Hood was filmed in 1922 and starred Douglas Fairbanks and Wallace Beery. With a tremendously lav-

ish set it was the first motion picture ever to have a Hollywood premiere and held at Grauman's Egyptian Theatre, 18 October 1922. It was one of the most expensive films of the 1920s, with a budget estimated at approximately one million dollars. The film was a smash hit and generally received favourable reviews. However our starlet is lost in the giant cast. I have placed a site where you can see a youtube snippet from the film in the "Sources" section. The film is still shown with an orchestra playing modern scores.


She later lived in Greenwich Village, New York until death in 1925. History remembers Ginny

She later lived in Greenwich Village, New York until death in 1925. History remembers Ginny as a Confederate spy who achieved great notoriety during the war. Highly active and considered by some to be a dangerous rebel, who at the time of her death retained a fierce pride for her beloved South.

A notice appeared in Greenwich Village Dallas Morning News, Texas 16 September 1925 by The Associated Press New York 15 September and referred to one of her nick names.

"Miss Ginger, 81, Confederate Spy, Dies Alone in Greenwich Village. A daredevil Confederate spy when a lovely girl in her teens. Miss Virginia B. Moon, 81, died here alone in her dark Greenwich Village apartment. Her death was brought to light by W. J. Baer, an elderly artist friend of hers, who read a death notice describing her as a veteran actress. His investigation resulted in the revelation that Miss Moon was found dead last Friday by Miss Martha Sawyers, a Texas stained

glass designer who lived on the first floor. The body was cremated Sunday and friends will send the ashes to her home in Memphis, Tenn. Miss Sawyers said she knew the woman who was known to half the Southland as 'Miss Ginger', an agnostic who had no fear of death, smoked innumerable cigarettes and boasted of the fourteen bona fide proposals she had spurned when a Southern belle and Confederate spy. Baer produced a sheaf of letters from Miss Moon to him dating back to 1902. She told of carrying morphine and dispatches through the





Union lines and twice wheedling her captors into releasing her with merely a warning. She wrote that she was first arrested in Cincinnati in 1862 by C. Kemper, one time General Grant's Chief of Staff. The letter is replete with the names of Federal officers who yielded to her charms and let her go." Oliver Jones, the husband of Miss Moon's niece said, "She died as much a rebel as ever." Oliver's wife was Virginia Warner also an actress. "He showed letters from Jefferson Davis commending Miss Moon, the 'Ginger Girl' for extraordinary heroism on behalf of the Confederate cause. Until six years ago, Miss Moon lived in Memphis. Then she was in the movies in Hollywood in Character parts. She came to New York to live a year ago-The Associated Press-New York."

Virginia Bethel Moon "Ginnie" is buried at Elmwood Cemetery, Memphis Tennessee. Born 22 June 1844 died 11 September 1925 aged 81. Memorial ID 8493683. She is a national treasure, I hope Memphis authorities acknowledge this. So far they seem to be blindfolded to their own history.

#### SASI Demands UM Administration Remove Confederate Statue at Ole Miss

The Students Against Social Injustice (SASI) organization, along with several members of the University of Mississippi's faculty and staff, formed a protest today to demand that the UM administra-

tion remove Ole Miss' confederate statue from campus grounds. SASI is the local chapter of the national student-led organization United Students Against Sweatshops (USAS). According to the group's mission statement, they are committed to providing a safe, welcoming environment for marginalized persons on campus. Hundreds of fliers appeared around campus Tuesday, Nov. 27 to promote awareness of "Steps for Justice", a Confederate statue protest taking place the next day. Dozens gathered in the Lamar Hall atrium at 11:30 a.m. Wednesday as protest organizers handed out signs that said "f\*ck the statue" and "take the statue down" as well as sheets of chants promoting justice.

Participants of the protest marched through campus with signs advocating for the removal of the Confederate statue. Protest organizer and SASI secretary Em Gill led by standing on the embankment outside Lamar Hall to educate the crowd of the demands SASI wants UM administration to make: 1) "The University of Mississippi administration must remove the Confederate statue from campus 2) Administration must implement a publicized hate speech policy to protect students from the racist violence we experience on campus 3) Regardless of who is in the Chancellor's position, administration will meet with us next semester to discuss these demands." "I was impressed with Em Gill and the SASI's organization of the event, the number of students, faculty and staff there, and I hope to see coalitions of groups continue to demand change on our campus in the future," said Hooper Schultz, graduate student and protest attendee. In Remembrance Word of the protest ignited the online community, as several voiced their support of the Confederate statue and those who lost their lives here during the Civil War. The statue was erected in 1906 by the United Daughters of the Confederacy, an American hereditary association of Southern women established in 1894 in Nashville.

Marching for Justice Gill and others led protesters along the walled-off entrance of the Student Union, by the Croft Institute and directly in front of the Confederate statue. She

told the crowd of supporters that although she is white, racism affects her and everyone around her. "None of us are equal until all of us are equal," Gill said. "All of us have identities that are privileged and oppressed. We all have a stake in this fight." On the Circle grounds, several students of color expressed personal stories why they believe the statue should be eliminated from campus. Bianca Martinez, an Ole Miss student, and Arquvas Williams, president of SASI, spoke to the crowd regarding discrimination both faced previously in their lives. "Two hundred years of hateful rhetoric has been too long," Martinez said. "It is time for change." The protestors continued their march from the statue through the Circle until they reached the steps of the Lyceum, home to the offices of the university's administration. Jessica Wilkerson, assistant professor of history and southern studies, took center stage to deliver a speech detailing the statue's history. She also named activists throughout history who fought for equality and listed reasons why the statue should be removed from the university's campus. "We love education and the [Confederate statute] does not educate us," Wilkerson said. Wilkerson concluded her speech by saying the statue commemorates and reveres the Confederacy and the institution of slavery. "[The statue] reveres a memory of the 'Old South' staked on the enslavement of black people," she said.

Protesters ended the march inside the front doors of the Lyceum with their demand letters in hand chanting, "What do we want? Justice!" Rod Guajardo, UM associate director of strategic communications, told Hottytoddy.com in an email university leaders received and reviewed SASI's letter. #### Ole Miss students demand 'hate speech' policy to shield from 'racial violence'

- The Students Against Social Injustice at the University of Mississippi made three demands during a recent campus protest.
- They asked for a "hate speech" policy, the removal of a Confederate statue, and a meeting with the administration during the spring 2019 semester.

Students at the University of Mississippi are demanding the college create a "hate speech" policy, claiming that doing so would protect students from the "racial violence" they experience on campus. During protests aimed at pushing the Ole Miss administration to remove a Confederate statue on campus, the student group Students Against Social Injustice (SASI), a local chapter of the national organization, Students against Sweatshops, made three demands, which included the creation of a hate speech policy, according to Hottytoddy.com. "The University of Mississippi administration must remove the Confederate statue from campus," SASI Secretary Em Gill said. The "administration must implement a publicized hate speech policy to protect students from the racist violence we experience on campus." "Regardless of who is in the Chancellor's position, administration [sic] will meet with us next semester to discuss these demands," he said, outlining the third demand. Ole Miss students held signs such as "Hate Speech isn't Limited to Speech," "Black Lives Matter," and "F\*ck Racism." University spokesman Rod Guajardo told HottyToddy.com that the school has obtained and reviewed the group's letter. "With final exams scheduled next week, [administrators] look forward to meeting with our students for a conversation sometime early in the new calendar year," Guajardo said. Jake Bennett, a student at Ole Miss, told Campus Reform that he thinks it would be a mistake to adopt a hate speech policy. "It would not be wise for Ole Miss to have policies restricting speech on campus," Bennett said. "As an Ole Miss student, I believe it would be foolish to entrust any university, especially in today's radically left-leaning academic climate, with the power of restricting any speech at all. It could lead to infringement upon individualism and diversity of thought, which are key aspects of our school and our society. Anyone who experiences serious threats or harassment should talk to law enforcement so they can handle it properly." This is n

The Right Way MS Agitators at the University of Mississippi have been organizing protests and race-baiting to stir up trouble since the 2018 US Senate runoff election on Nov 27th. In that election, Republican Sen. Cindy Hyde-Smith, who was appointed by Gov. Phil Bryant, defeated Democrat Mike Espy. The race was forced into the national spotlight by the opportunistic Liberal Mississippi Media and Sen. Hyde-Smith, who made remarks during her campaign that some interpreted as racially insensitive. Arguably two of the greatest men and Generals in American history. Although born on opposite sides of Virginia and definitely from different social cultures, each demonstrated leadership traits and cunning skills on the battlefield. Long before the War for Southern Independence, each man caught the eye of his Commander for the skill they possessed in their areas of expertise but more importantly, how they conducted themselves with honor. Because Lee was following in the footsteps of a famous father, great expectations by family and friends would always follow him. For anyone who reads the biography and other publications of Lee know that he surpassed all expectations and showed an uncanny ability to lead his men to victory or to snatch victory away from his foe. Jackson grew up as a somewhat timid youngster but as he aged he became two men in one. On the battlefield, timid would not be a word used to describe Jackson. One of the more notable phrases attached to Jackson was "Give them the bayonet". His forced marches of long distances and the always pushing forward brought criticism from some subordinates but in case after case preserved the army and caught his opponent off guard. Away from the scene of battle Jackson showed a tender loving side to his family and although not always as evident, his troops. A strict disciplinarian, Jackson levied that discipline fairly upon the men under his command. Religion was a big part in his life as he grew into adulthood but was not as evident in his early life. Together Lee and Jackson made a brilliant team. After Jackson's death there would be a void in the Army of Northern Virginia that would not be filled. The one weakness that Jackson had was in the training of his subordinate officers. In later battles this would become evident and would cost Lee and his army. After the war, Lee continued to show the nation what he was made of. Although his family lost almost every worldly possession, he held his head high with pride. While at Washington College his leadership traits again came to the forefront. Students revered him for the man he was. Across the South, the birthdays of Robert Edward Lee and Thomas Jonathon Jackson became holidays. Entire towns would stop and pay homage to these two great men. In Mississippi we continue this tradition with observance of a state holiday even as detractors try to tear down the image of these men. Try to perpetuate the memory of these men by sending a letter to the editor of your local newspaper reminding him that this is a State Holiday and recognition should be given to the accomplishments of both of these men. As political forces gather to take away the history of the South, this is where they start. A slow removal of all things Southern that we take for granted. Large crowds used to gather, how many will there be today?

#### LEE / JACKSON'S LAST MEETING

Having seized the initiative, on the night of May 1, 1863, Robert E. Lee and "Stonewall" Jackson met to make plans for the next day. They had 45,000 men to fight Joe Hooker's 90,000 soldiers on this part of the battlefield. Learning that Hooker's right flank was vulnerable, Lee decided to send Jackson with 30,000 men to attack the Union weak spot.

The meeting lasted much of the night. According to tradition, Lee and Jackson sat on cracker barrels during part of the conference. Afterwards the generals got a brief sleep. The next morning, James Power Smith of Jackson's staff noted that Jackson had a fever.

Early on the morning of May 2, Lee and Jackson met for the last time. As Jackson led his men down to Furnace Road, Lee never saw Jackson again. This famous sketch of the last meeting captures the spirit of the moment, but the hills in the background are a figment of the artist's imagination.

#### <u>CAUSES FOR MISSISSIPPI SECESSION – JANUARY 9, 1861</u>

In the momentous step which our State has taken of dissolving its connection with the government of which we so long formed a part, it is but just that we should declare the prominent reasons which have induced our course. Our position is thoroughly identified with the institution of slavery-- the greatest material interest of the world. Its labor supplies the product which constitutes by far the largest and most important portions of commerce of the earth. These products are peculiar to the climate verging on the tropical regions, and by an imperious law of nature, none but the black race can bear exposure to the tropical sun. These products have become necessities of the world, and a blow at slavery is a blow at commerce and civilization. That blow has been long aimed at the institution, and was at the point of reaching its consummation. There was no choice left us but submission to the mandates of abolition, or a dissolution of the Union, whose principles had been subverted to work out our ruin.

That we do not overstate the dangers to our institution, a reference to a few facts will sufficiently

The hostility to this institution commenced before the adoption of the Constitution, and was manifested in the well-known Ordinance of 1787, in regard to the Northwestern Territory.

The feeling increased, until, in 1819-20, it deprived the South of more than half the vast territory acquired from France. The same hostility dismembered Texas and seized upon all the territory acquired from Mexico.

It has grown until it denies the right of property in slaves, and refuses protection to that right on the high seas, in the Territories, and wherever the government of the United States had jurisdiction.

It refuses the admission of new slave States into the Union, and seeks to extinguish it by confining it within its present limits, denying the power of expansion.

It tramples the original equality of the South under foot.

It has nullified the Fugitive Slave Law in almost every free State in the Union, and has utterly broken the compact which our fathers pledged their faith to maintain.

It advocates negro equality, socially and politically, and promotes insurrection and incendiarism in our midst.

It has enlisted its press, its pulpit and its schools against us, until the whole popular mind of the North is excited and inflamed with prejudice.

It has made combinations and formed associations to carry out its schemes of emancipation in the States and wherever else slavery

It seeks not to elevate or to support the slave, but to destroy his present condition without providing a better.

It has invaded a State, and invested with the honors of martyrdom the wretch whose purpose was to apply flames to our dwellings, and the weapons of destruction to our lives.

It has broken every compact into which it has entered for our security.


It has given indubitable evidence of its design to ruin our agriculture, to prostrate our industrial pursuits and to destroy our social sys-


It knows no relenting or hesitation in its purposes; it stops not in its march of aggression, and leaves us no room to hope for cessation

It has recently obtained control of the Government, by the prosecution of its unhallowed schemes, and destroyed the last expectation of living together in friendship and brotherhood.

Utter subjugation awaits us in the Union, if we should consent longer to remain in it. It is not a matter of choice, but of necessity. We must either submit to degradation, and to the loss of property worth four billions of money, or we must secede from the Union framed by our fathers, to secure this as well as every other species of property. For far less cause than this, our fathers separated from the Crown of Fngland.

Our decision is made. We follow their footsteps. We embrace the alternative of separation; and for the reasons here stated, we resolve to maintain our rights with the full consciousness of the justice of our course, and the undoubting belief of our ability to maintain it.
